If you are unable to get info turned in on time to follow that schedule, the manager from the school will reach out to you as soon as the application is received. Please note..... this meal distribution differs from the serving of meals we did March- June. We must follow the National School Lunch Program regulations set in place for the new school year. All students wishing to participate must have enrollment in schools verified before they can be served.

The pickup schedule is limited as the cafeterias are also having to prepare and serve meals daily at the schools. Due to these time constraints, all schools will be distributing these meals between 9-10am, with the exception of Luttrell which will be from 11am-12. Clean up and preparation for the next day keep us from distributing in the afternoon.

We understand the start of school is quickly approaching, so please fill out this survey as soon as possible and we will do our best to serve following the projected schedule. As with all things in the current situation, changes may need to be made. Please be patient as we will do our best to provide meals to all students who wish to participate.
